Insurance & Financial Responsibility Agreement

Insurance is a critical part of what makes Golden Wings Incorporated a viable organization, allowing the club to provide aircraft for rent at reasonable rates. With that in mind, each member must understand and agree to the limitations set forth by the club and its insurer before operating a club aircraft. Please read this form, sign below, and return the form with your application for membership or renewal. Membership in the club cannot be completed until this form is received with your dated signature.

As a part of my membership to Golden Wings Inc. (club), I (member) understand and agree that:

- 1) Only club members and certified flight instructors that are training me are insured to operate a club aircraft; non-members, whether they are pilots or not, are not insured to operate a club aircraft.
- 2) If my medical, or any aspect of my flight currency (including but not limited to BFRs and basic, night, and instrument currency, as specified in the FARs) has lapsed or is not fully current, operations in a club aircraft are not insured and are prohibited. If I execute such an operation in a club aircraft, the club will consider that aircraft as being operated without the club's permission.
- 3) In addition to being current under FAR 61.56, I need to have some aspect of flight instruction every year. That flight instruction can take the form of a BFR, an IPC, an FAA Wings Program endorsement, a check-out in a new aircraft or any other form that assures that I have logged time with a flight instructor.
- 4) Using a club aircraft for money or for hire, whether carrying people or cargo, other than payment for those items specifically outlined in Part 91 of the FARs, is not insured and is prohibited. If I execute any such operation in a club aircraft, the club will consider that aircraft as being operated without the club's permission.
- 5) I will not fly a club aircraft unless I possess an effective Pilot Certificate and the required flight experience, as outlined in the club's minimum experience sheet, for that aircraft. If I fly any club aircraft without an appropriate and current Pilot Certificate and/or do not meet the minimum experience requirements, the club will consider that aircraft as being operated without the club's permission.
- 6) I am personally and financially responsible for any uninsured operation of club aircraft, or any operation for which I do not have the club's permission.
- 7) The club will pursue, to the fullest extent of the law, collection of all damages, fees and costs associated with any damage or liability claims from any and all operations for which insurance is denied because of my conduct. Further, I understand and agree that any legal fees and costs for pursuing collection shall be owed to the club if it prevails on a claim against me.
- 8) I will demonstrate the responsibility with respect to my financial obligations with the club by prompt payments of amounts due to the club; if I do not, the club may require me to take steps to assure that I meet my obligations.
- 9) I have received, read, understand and agree to abide by the Golden Wings, Inc Bylaws and Operational rules. In particular, I understand that I am financially responsible for any damage or abuse to Club aircraft that I am using. I further understand and agree that I shall not seek to hold the Club legally responsible for my acts while operating club aircraft that result in damages or injuries, whether to others or myself. In the event any damages are assessed against the club as a result of my acts or negligence, I shall be solely responsible for the payment of damages and for any legal fees or costs incurred by the Club in defending against such claims. I understand that if I am the member pilot of any Club aircraft, I am responsible for my own medical expenses resulting from any personal injuries I sustain. The Club strongly recommends that every Club member obtain medical coverage.
- 10) I understand that I will be eligible for a refund of all unused dues only after I have been a club member for three consecutive months.

I certify that all the information on this application is true and correct to the best of my knowledge. I understand that any falsification shall be grounds for disqualification or forfeiture of membership. I have read and agree to the ten items above. I understand that falsification of this application may invalidate my insurance coverage and be cause for forfeiture of fees and privileges of membership in Golden Wings, Inc. I further certify I am current as to FAR 61.56 (or will be before flying without a CFI), and that I have received and read, understanding and agree to abide by, the operational rules and bylaws of the club.
